They had two children (1) Graneta Marie Bilbo born August 4, 1917 (2) V.C. Bilbo Jr. born March 22, 1921.

Cemetery News

The Smith Cemetery . 22 acres on land that was a part of their Peters Colony land grant now has a fence around it and a large, very visible, marker on it. This site on Illinois was endangered by the owners of the surrounding land who wanted to use it for parking spaces. Joe and Donna Spears who live in Argyle, Texas took the company to court and won.

There were only parts of three headstones that had not been moved when Donna, the descendant, found the site. She had access to the original deed in 1877 for the family grave yard, the distribution of the land and the family members who had been buried on this site. A Historic Texas Marker has been applied for, for this site.

In March there was an article in the Dallas Morning News about flooding at the city owned pauper's cemetery behind some buildings on Lombardy Lane. This site is where the people who died at Parkland were buried in the 1930s and 40s. Karen Riggs made an inventory of this cemetery when she found it in 2004. Karen was looking for the gravesite of her grandmother who lived in Oklahoma but had been visiting in Dallas when she died. Karen came to a DCPA meeting and left a copy of the site inventory.

Due to all the rain we had this spring there was standing water on many of the graves. The Park Department maintains this site and to fill in the low places would destroy the gravesites that are marked with a small six inch metal marker. A section is where the infants are buried with no marker at all.

If the weatherman permits it, there "will be /was" rededication of two new headstones for the Akard family at the Pioneer Cemetery on May 14, 2015. The original headstones were broken through the years, but the pieces had been saved by the Park Department that maintains the site. About the same time I discovered the broken stones in the lower level DCPA was contacted by John Akard who lives in Houston and he had been in Dallas and could not find the gravesite for his grandfather.

The old broken pieces could not be repaired so new headstones were made and set in the original location. John Akard will be at the location and the Dallas Historical Walking tour of the Pioneer Cemetery will be led by DCPA member Paul McLin.

A meeting was held in City Councilwoman Jennifer Staubach Gates office April 7,2016. DCPA member Fred Lusk had made contact with State Representative Sheets about the Storm Water Run Off fee that appeared on Dallas County Cemeteries. Sheets contacted Mrs. Gates. In attendance in the meeting was a city staff Sarah Standifer who was working on the problem for a year. Hopefully this will be solved soon and the small private cemeteries will be free of this monthly charge.


New History at Old Red Conference September 17, 2016



Judge John Bookhout

Judge John Bookhout and his wife Mary Ella Randall were married on 12/14/1875 and had 8 children. He died 3/13/1918. Judge Bookhout's home was at St. Paul and Munger streets in Dallas. Associate Justice John Bookhout, of the Fifth Court of Civil Appeals, in Dallas is buried in Oakland Cementary in Dallas. The first telephone on the 1881 Dallas system was in the office of Judge John Bookhout at the northwest corner of Main and Lamar Streets. Bookhout street in Dallas is named for him.
